Some of his other mentors include Jeffery Meyer, John Nardolillo, Thomas Heuser, Roger Kalia, Mark Gibson, and Kenneth Kiesler.

He is married to his wonderful wife and has two young boys. He also enjoys composing, playing basketball, and skiing.
